### NOTIFICATION CLAT 2026 - FINAL ANSWER KEY

The Consortium constituted a Subject Expert Committee to review the objections filed by the UG applicants and another Subject Expert Committee to review the objections filed by the PG applicants against the Provisional Answer Key and the Questions. The recommendations of the Subject Expert Committees which reviewed the objections to the questions and answer keys received from the candidates, were placed before the Oversight Committee for its decision. The Oversight Committee chaired by Hon'ble Mr. Justice V. Gopala Gowda, Former Judge, Supreme Court of India considered those recommendations and resolved to consider the following modifications in the Answer Keys of PG - CLAT 2026.

The Governing Body of the Consortium of National Law Universities reviewed those recommendations received from the Oversight Committee and approved the following modifications recommended by the Subject Expert Oversight Committee.

### CLAT 2026 - UNDERGRADUATE

There is no change in the provisional answer key or to any question published on 10<sup>th</sup> December 2025. Therefore, the provisional answer key published is considered as final. Accordingly, the evaluation of candidates for the CLAT 2026 UG shall be out of 119 marks.
